

# Centrelink – Voluntary Work Application Mentoring for The L2P Program

If you are considering applying to be a Mentor under the Centrelink agreement with Energy Education Australia Incorporated, and hold a current South Australian Drivers Licence, please read fully the following information.

## All Mentors need to meet the following guidelines approved by the South Australian Government.

Mentors to have current certificates or completed checks for the following:

1. DHS Screening checks  
minimum Volunteer status for Working with Children and or Youth
2. RAN Training – Reporting to Abuse and Neglect  
minimum Volunteers status
3. Driver History Check  
Under taken by Service SA
4. Two hour Driver Practical Session  
Conducted by L2P's South Australian MDI contractor

Costs for the above are covered and conducted by the L2P program.

### **L2P reserves the right to request fresh RAN Training and/or DHS Screening Clearances.**

You will also be required to:

- complete a Mentor Application form
- attend an interview with an L2P administrator
- submit a copy of your medical information
- submit a signed consent to release personal information

If you accept the above conditions and have the required clearances and checks, L2P will arrange additional training before allocating you a mentee or mentees to fulfil your obligation to Centrelink.

***Please be aware that L2P is under an obligation to report YOUR attendance with the L2P program as a Centrelink Volunteer.***
